PRIVILEGE OF THE FLOOR

A speaker reiterated a litany of complaints and allegations against virtually all of Town government demanding that the Board launch an investigation into the alleged corruption and abuse of power. Supervisor Schaffer thanked the speaker for his comments but refused to respond due to the outrageously erroneous, inflammatory and slanderous nature of the accusations.

A speaker asked for an update on the requirement for Warren Realty to install fencing and other natural buffers at the rear of their property on the Parkway.

Supervisor Shaffer noted that the company has ordered the materials and that they are working with the Town Engineer on the timeline to complete the project.

A speaker stated that on his way to tonight's meeting, he noticed that a number of street lights were out in the areas of the shopping malls on the Parkway. Supervisor Schaffer responded that most of these lights are either on private property of are under the control of the State. We routinely notify the State if we are made aware of lights that are not working.
